## PURPOSE

MEADOW COURT STAFF WISH THE INDIVIDUAL TO HAVE A SUCCESSFUL AND HAPPY STAY HERE AND WISH TO HELP THE INDIVIDUAL ACHIEVE A LIFE THAT BOTH IMPROVES AND STIMULATES THE INDIVIDUAL TO ATTAIN EMOTIONAL STABILITY AND FUTURE PROGRESS.

IN ORDER TO HELP TO PROGRESS THEIR WE AGREE THE FOLLOWING:

MEADOW COURT ALSO GUARANTEES THAT IF THE INDIVIDUAL WISHES TO LEAVE AT ANY TIME, WE WILL NOT SEEK THE INDIVIDUAL TO GIVE NOTICE, SO HE CAN LEAVE AT ANY TIME, STAFF WILL ALSO HELP THE INDIVIDUAL FIND ALTERNATIVE ACCOMMODATION IF REQUIRED



## BEHAVIOUR AND HARM TO INDIVIDUALS AND FACILITIES

1. THE INDIVIDUAL WILL MANAGE THEIR BEHAVIOUR IN A WAY WHICH MINIMISES DAMAGE TO PROPERTY AND THERE IS NO TREAT TO PEOPLE
2. THE INDIVIDUAL WILL SEEK TO TALK TO STAFF RE: THERE EMOTIONAL NEEDS TO PREVENT HARM TO PEOPLE AND PROPERTY
3. ANY WILLFUL DAMAGE, TREATS OR HARM TO OTHERS WILL CAUSE THE TERMINATION OF TENANCY AND IN TRAUMATIC SITUATIONS WILL BE AN INSTANT MOVE WHERE POLICE ARE INVOLVED AND AN ARREST TAKES PLACE
4. THE INDIVIDUAL WILL NOT DAMAGE THE FLAT, STRUCTURE, FITTING AND EQUIPMENT
5. THE INDIVIDUAL WILL NOT DAMAGE ANY OTHER FACILITY AT MEADOW COURT



## ACTIVITIES

1. THE INDIVIDUAL WILL KEEP THEIR FLAT IN GOOD CONDITION AND ALLOW STAFF TO HELP HIM MAINTAIN THEIR FLAT THREE TIMES A WEEK
2. STAFF WILL HELP THE INDIVIDUAL TO USE LAUNDRY FACILITIES TO MAINTAIN THEIR STANDARD OF HYGIENE AND CLEANLINESS
3. THE INDIVIDUAL WILL TAKE PART IN AN ACTIVITY AT LEAST ONCE A WEEK WHICH WILL INCLUDE VISITS TO TAUNTON OR ELSEWHERE FOR SOCIAL ACTIVITIES. STAFF WILL ENCOURAGE THE INDIVIDUAL TO TAKE PART IN ALL ACTIVITIES OVER AND ABOVE THEIR.
4. THE INDIVIDUAL WILL PARTICIPATE IN AT LEAST ONE COOKING SESSION A WEEK, WHERE HE WILL BE INVOLVED WITH STAFF TO MAKE A MEAL FOR THEMSELVES/OTHERS



## ACTIVITIES

### FINANCE AND BUDGETING

1. THE INDIVIDUAL WILL MANAGE THEIR BUDGET TO ENSURE HE HAS ENOUGH RESOURCES TO GET HIM THROUGH THE PERIODS BETWEEN PAYMENT
2. STAFF WILL WORK WITH THE INDIVIDUAL TO HELP HIM BUDGET THROUGH PLANNING OF THEIR SPENDING NEEDS OVER THE BUDGET PERIOD
3. THE INDIVIDUAL MUST ALLOW STAFF TO HELP HIM, INCLUDING NOT PURCHASING ITEMS WITHOUT STAFF ACKNOWLEDGEMENT IN ORDER TO ENSURE HE HAS ENOUGH PERSONAL MONEY FOR FOOD AND OTHER NECESSARY ITEMS, SO HE HAS NO NEED TO BORROW FROM OTHERS INCLUDING MEADOW COURT RESOURCES
